

## **Ninja Challenge Terms and Conditions**

By participating in Ninja Challenge of AIA One Billion Week (“Event”), you agree that these activities in the Event are undertaken at your own risk and you accept the following terms and conditions related to the Ninja Challenge, AIA One Billion Week (<https://www.aia.com.hk/content/dam/hk-wise/pdf/campaign-and-events/aob/aob-week-tnc-en.pdf>) and the Hong Kong Observation Wheel (<http://hkow.hk/terms-conditions/>). Please act within your abilities and stay safe.

### **Registration Instructions**

1. All activities have limited slots, so please register early.
2. All tickets are free, and each ticket of a registered activity entitles for one (1) person’s admission only. Please show the confirmation e-mail / QR Code on the ticket for verification by the on-site staff.
3. To allow more members of the public to participate in this activity, each participant can only book a maximum of two tickets each time.
4. Ninja Challenge Timed Challenge is only suitable for individuals aged 16 or above.
5. For the Ninja Challenge Workshop, participants aged 10 or below must be accompanied by a parent or guardian.
6. Participants aged below 18 must have their registration form filled out by a parent or guardian. Contact Information refers to the parent/ guardian’s information, while ticket information refers to the participant’s information (Email address must be the email address of parent/ guardian’s).
7. With your written consent, the personal data may be used for direct marketing purposes. For more details on AIA International Limited (acting through its Hong Kong branch) and Zicket's policy for the use of personal data for direct marketing purposes, please refer to the AIA [Personal Information Collection Statement](#) and [Zicket Privacy Policy](#).
8. In the event of any disputes, AIA reserves the right to make final judgment on the disputes and other registration matters.
9. AIA reserves the absolute right to modify and cancel the Event. In case of cancellation, you will be notified via email.

### **Safety Rules**

1. Participants must wear appropriate sports attire and lightweight athletic shoes, and it is recommended to bring personal protective gear such as gloves or knee pads according to individual needs.
2. Only one person is allowed on each obstacle at a time.
3. To avoid congestion, participants must not gather around the obstacles.
4. Participants must follow the designated Ninja Challenge course sequence and use the obstacles as intended. Avoid any reckless or dangerous behaviour, and do not hang, swing, or climb on structures that are not part of the obstacles.
5. Participants must follow the instructions and recommendations of the activity staff. In case of a fall or injury, participants must immediately inform the activity staff.
6. Professional coaches of the Ninja Challenge reserve the right to cancel the participation of any individual deemed unsuitable due to age or ability issues, and the individuals concerned must accept the coach's final decision.
7. The Ninja Challenge Workshop is suitable for participants aged 6 to 60, while the Ninja Challenge Timed Challenge is suitable for participants aged 16 to 60.

8. Participants must respect and consider other participants in the Ninja Challenge Workshop or Ninja Challenge Timed Challenge.
9. No Running, playing, or disruptive behaviour is allowed within the venue. Participants must follow all posted signs and adhere to the instructions of the activity staff.

#### **Adverse Weather Arrangements**

1. If any Typhoon Signal No. 3 or above, and/ or Black Rainstorm Warning is still in force three hours before the opening of AIA One Billion Week, the Event will be suspended for the entire day.
2. If during the Event, the Hong Kong Observatory announces that Typhoon Signal No. 3 and/or Black Rainstorm Warning will be hosted, AIA One Billion Week will close immediately within an hour.
3. If any activity at AIA One Billion Week, including Ninja challenges, football classes and interest classes, etc., is suspended due to the aforementioned adverse weather conditions, registered participants will receive an email notification regarding the cancellation. Participants must also regularly check [aia.com.hk/AOB](http://aia.com.hk/AOB) for updates on adverse weather arrangements.

#### **Accident Disclaimer and Liability Waiver**

1. Participation in the Event is voluntary. Participants assume all risks and responsibilities. Except as required by law, under no circumstances shall we be liable for any accident, damage, loss, or personal injury suffered by you, whether the same is caused by our negligence or otherwise, nor shall we be liable for any damage, loss, or personal injury resulting from any other cause.
2. By registering to participate in the AIA One Billion Week, you agree that these activities in the Event are undertaken at your own risk and you agree to the following terms and conditions:

#### **Physical Condition Declaration**

- You warrant and represent that you are in good physical condition, that you know of no medical or other reasons why you are not capable of engaging in active or passive exercise, and that such exercise will not be detrimental to your health, safety, comfort, or physical condition. You further represent and warrant that you suffer from no physical impairment that would prevent your use of the AIA One Billion Week facilities or adversely affect your decision to participate in any activity at the AIA One Billion Week.
- You agree that if you engage in any physical exercise or activity, for any purpose, you do so at your own risk and assume the risk of any and all injury and/or damage you may suffer, whether while engaging in physical exercise or not. This includes injury or damage sustained while and/or resulting from using any premises or facility, or using any equipment, whether provided to you by a trainer or otherwise, including injuries or damages arising out of the negligence of the trainer, whether active or passive, or any of the trainer's affiliates, employees, representatives, successors, and assigns.
- You agree not to use AIA One Billion Week facilities while suffering from any infection, contagious illness, disease, or other ailment including (without limitation) open cuts, abrasions, open sores, or other minor infections, where

there is a risk that such use may be detrimental to health, safety, comfort, or physical condition of other users.

- AIA reserves the right to refuse entry to any person for safety, health, or security reasons, and you agree to hold harmless AIA from any and all claims, damages, or liability arising from such refusal.
  - The use of all the AIA One Billion Week facilities is entirely at your own risk. Use of the specialist facilities within the AIA One Billion Week may result in harm to you, especially if you are not familiar with the proper use of particular facilities. You should not use any of the facilities if you are not sure about the safe and proper use thereof.

  4. AIA may, at its discretion, amend, vary, delete, or add to these Terms and Conditions from time to time.
  5. In the event of any inconsistency or conflict between the English and Chinese versions of these Terms and Conditions, the English version shall prevail.
  6. These Terms and Conditions shall be governed by and construed in accordance with the laws of the Hong Kong Special Administrative Region of the People's Republic of China.
